## ELECTION OF MAYOR FOR THE 2008/2009 MAYORAL TERM

### EXECUTIVE SUMMARY

<b>PURPOSE OF REPORT:</b>	To elect the Mayor for the period 2008/2009.
<b>BACKGROUND:</b>	Section 290 of the Local Government Act provides that Council shall elect a Mayor and the Council is required to hold Mayoral elections in September of each year of its four year term.
<b>COMMENTS:</b>	It is customary in Ku-ring-gai Council for Mayoral elections to use the ordinary ballot method of voting.
<b>RECOMMENDATION:</b>	That the Council elect the Mayor for the period 2008/2009 using the ordinary ballot method.

## PURPOSE OF REPORT

To elect the Mayor for the period 2008/2009.

## BACKGROUND

Section 290 of the Local Government Act provides that Council shall elect a Mayor and the Council is required to hold mayoral elections in September of each year of its four year term.

## NOMINATION

Schedule 7 - Election of Mayor by Councillors [Local Government (General) Regulations 2005] states:

2. *(1) A councillor may be nominated without notice for election as mayor or deputy mayor.*
- (2) The nomination is to be made in writing by 2 or more councillors (one of whom may be the nominee). The nomination is not valid unless the nominee has indicated consent to the nomination in writing.*
- (3) The nomination is to be delivered or sent to the returning officer.*
- (4) The returning officer is to announce the names of the nominees at the council meeting at which the election is to be held.*

Nomination forms and Acceptance forms have been distributed with the Business Papers and will also be available on the night.

If there is more than one nomination, an election is carried out.

## METHOD OF ELECTION

The election could be carried out in one of three ways.

The first is an ordinary ballot. In this type of election, each councillor is required to cast one vote for the candidate of his or her choice. If there are more than two candidates, the candidate who polled the lowest number of votes is eliminated and a further ballot takes place. In the case of a tied vote (ie 5 all for the final two candidates), the General Manager will conduct a draw of lots to determine the outcome - the one chosen by lot is elected Mayor. at any stage through the vote, if 2 or more candidates are tied on the lowest number of votes, the one to be excluded is chosen by lot.

The second possible method of voting is a preferential system. In this system each councillor is required to cast a vote listing the candidates in order of preference 1, 2, 3, etc. If no candidate receives an absolute majority of first preferences, then preferences are distributed until one candidate receives a majority.

The third possible method of voting is open voting. This voting method follows the same principles as the ordinary ballot, except that voting is conducted by Councillors raising their hands for the candidate of their choice.

### EXECUTIVE SUMMARY

**PURPOSE OF REPORT:**

To elect the Deputy Mayor for the period 2008/2009.

**BACKGROUND:**

Section 231 of the Local Government Act 1993 empowers the Council to elect a Deputy Mayor.

The Deputy Mayor may be elected for the same term as the Mayor or a shorter period.

Traditionally, Ku-ring-gai Council has elected a Deputy Mayor for the same period as the Mayor, ie annually.

**COMMENTS:**

It is customary that the same method of voting as is used for the election of the Mayor is used to elect the Deputy Mayor.

**RECOMMENDATION:**

That Council elect the Deputy Mayor for the period 2008/2009 using the same election method as was used for the election of the Mayor.

At any stage through the vote, if 2 or more candidates are tied on the lowest number of votes, the one to be excluded is chosen by lot.

The second possible method of voting is a preferential system. In this system each councillor is required to cast a vote listing the candidates in order of preference 1, 2, 3, etc. If no candidate receives an absolute majority of first preferences, then preferences are distributed until one candidate receives a majority.

The third possible method of voting is open voting. This voting method follows the same principles as the ordinary ballot, except that voting is conducted by Councillors raising their hands for the candidate of their choice.



Broken Hill welcomes all delegates and visitors to the 2008 Local Government Association Conference to our city. The City is very proud to host this significant conference.





## Invited Keynote Speakers



### **Karsten Gerkens,**

Director, Office of Urban Regeneration and Residential Development, Leipzig City Council, Germany

Karsten Gerkens has been the Director of the Office of Urban Regeneration and Residential Development for Leipzig City Council, Germany, since 1991. The office operates national and European funding programs within 15 reconstruction areas

comprising 550 ha of inner city "Gründerzeit" areas and several large scale prefabricated housing developments.

The 3 phases of Urban Renewal Karsten has been involved with for the City of Leipzig, include Reconstruction of Buildings, Investment in Residential Environment and Redevelopment of the City.

Some of the main tasks have been to save the old housing stock which had seen no repair since the end of the second world war. 75% of the apartments in the city needed reconstruction. This apartment renovation work also required a total upgrading of the environmental and infrastructure systems.

Leipzig had become a "shrinking city" - one of Karsten's main objectives was to turn that around - Leipzig is now growing again.



### **Kate Joncas,**

President of the Downtown Seattle Association, Seattle, USA

Kate Joncas has been President of the Downtown Seattle Association since 1994. Kate has over 30 years experience in downtown revitalization in the private, public and nonprofit sectors in communities around the world.

Ms. Joncas has written workbooks on market analysis, business recruitment, business improvement districts and Downtown housing. She has won awards in national competitions for urban designs in Boston and St. Paul.

Ms Joncas is the past Chair of the International Downtown Association and current chair of their International Committee. Friday 10th May, 2008: 9.00am - 2.30pm



The Sydney 2000 Olympic Games were applauded as the 'best Games ever' and tagged the first 'green Games'. The vision for Sydney Olympic Park is to become an internationally admired example of sustainable urban renewal and development, as it moves from the gold medal sporting and events precinct to a vibrant township.

Development of the town centre is proceeding rapidly with \$1 Billion committed for commercial and residential development. Over the next 10 to 15 years, a further \$7 Billion in spending is anticipated on new developments for commercial, residential, educational, retail and venue purposes.

On this field trip, delegates will get the chance to examine Sydney Olympic Park from three different perspectives:

1. the planning process involved in creating the Masterplan for the site's development;

2. the business development of the site as a Sports Town and Education Campus; and
3. the initiatives of environmental sustainability built into the site which enabled delivery of the Green Games.

The Park's environmentally sustainable initiatives will be covered by a coach tour around the 620 hectare site with expert commentary provided. The other two information sessions (the Masterplan and Sports Town/ Education campus) will be a mix of seminar and short walking tour.

Carlo Ratti is a civil engineer, architect and director of the Massachusetts Institute of Technology's SENSEable City Laboratory.

SENSEable launched the Real Time Rome project at the 2006 Venice Biennale, which employed data from mobile phones, buses and taxis to render immediate imaging of urban dynamics across an evening in Rome.

Carlo Ratti's many current projects are focussed on real-time, location sensitive tools for understanding cities. His latest project, New York Talk Exchange (NYTE), is on exhibit at New York City's Museum of Modern Art.

NYTE compares socio-economic and ethnic profiles of New York City's five boroughs with data collected from telecommunication networks to reveal the connected relationships that New Yorkers maintain with cities from around the world.

## Technical Tours

A number of technical tours are being prepared to provide insight into some of Sydney's larger urban developments. They are likely to include the redevelopment of former inner city docklands and the CBD/airport corridor, as well as the former Olympic Games site.

- Barangaroo in East Darling Harbour is a 22-hectare former stevedoring wharf at the edge of the Sydney CBD. An international design competition was held to guide the renewal of this important site as an extension of the CBD. Fifty per cent of the site will be allocated to public open space. The project is still in the planning and design stages.
- Victoria Park is an ambitious undertaking designed to accommodate a rapidly changing housing market in Sydney. The project is being used to develop and prove a range of cutting edge design and environmental features.
- Prince Henry, Little Bay is 85 hectares of coastal land once occupied by a hospital. Approximately 25 minutes from the Sydney CBD, the site is being developed into a sustainable residential community. Heritage buildings and historic landscapes are being designed to blend with contemporary coastal buildings.
- Sydney Olympic Park, the main venue for the hugely successful 2000 Olympic Games, represents an exceptional opportunity for the city to establish a best practice example of sustainable urban development. It is building on the park's world-class initiatives in energy and water management, green building design, ecological management and the healthy lifestyle provided by the precinct's sporting facilities and 425 hectares of urban parkland.
