3. Maintenance including repairs and parts replacement will be provided by Council, however reasonable care of the bin shall be taken by the resident.
4. An additional charge will be levied on a pro-rata basis from the commencement date of the additional service. This will be charged to the rates account.  
If you are not the owner of the property please have the owner or agent request the service on your behalf. The current charge is \$185.00 pa per bin **[24/25 financial year]**
5. The service will not commence until Council has received this signed agreement form.
6. The minimum term for this additional service is 1 year from date on this agreement.
