To have Council consider its position in response to the NSW Minister for Planning's intention to give the Ku-ring-gai Planning Panel the reclassification powers under section 118(3) 9(b) of the Environmental Planning and Assessment Act, 1979.

- A. That Council makes a submission to the Minister for Planning in relation to his letter of 12 July 2010 asking Council to show cause why the Ku-ring-gai Planning Panel's powers should not be expanded to include the reclassification powers under the Local Government Act, 1993 based on the matters outlined in this report under the heading "Show Cause Letter".
- B. That Council notes the Department of Planning's recommendation to return the DA determination role to Council. In regard to the concern over a number of minor applications exceeding 90 days referred to the Ku-ring-gai Planning Panel, it is noted that this amounted to only seven (7) Development Applications during the term of the Ku-ring-gai Planning Panel ie from February 2008 to date. In many instances, the delays were as a result of applicants not providing

additional information to Council in a timely manner. Seven (7) applications in this category represents only 0.2% of the total of 3,280 applications assessed and determined by Council during the term of the Ku-ring-gai Planning Panel. In the context of the Department's own 2008/09 Local Development Performance Monitoring Report which demonstrates not only that Council's DA processing times have improved but that Ku-ring-gai Council, with a median DA turn-around time of 37 days, is the third fastest among the 43 Councils in the Greater Sydney Region.
