Fox Valley Road, Wahroonga - Proposed 'No Parking' restrictions in the cul-de-sac area.

Council is seeking your input on the proposal to introduce 'full-time No Parking' restrictions in the cul-de-sac area of Fox Valley Road, Wahroonga.

## **Background**

Council has received correspondence regarding the difficulties vehicles encounter at the end of Fox Valley Road, specifically within the turning circle. It has been commented that when vehicles are parked along the street and in the turning circle, insufficient space remains for delivery vehicles and waste trucks to execute a turn. A resident reported witnessing trucks reversing the entire length of the road back to The Broadway (over 150 metres), creating a safety concern for motorists and pedestrians.

This section of Fox Valley Road measures 8.2 metres in width, accommodating unrestricted parking on both sides. Its proximity to Fox Valley Shopping Centre, SAN Hospital, and Parkway SAN Clinic contributes to significant parking demand.

Site inspections have confirmed that vehicles frequently park on both sides of the street and within the cul-de-sac, hindering the safe navigation of vehicles around the turning circle.

## **Proposed changes**

To address this issue, it is proposed that 'full-time No Parking' restrictions be implemented at the end of Fox Valley Road. This measure will prevent motorists from parking too close to and in the cul-de-sac, ensuring adequate space for vehicles wishing to make U-turns after reaching the dead end of the street. The proposed arrangement will not result in the loss of any legal parking spaces.

The **Attached** Plan No. Fox-Valley/TDA45/25 shows the proposed arrangement.
