agree to Ku-ring-gai Council providing a larger [240L] domestic waste bin subject to the below conditions:

1. The bin shall remain the property of Ku-ring-gai Council. **In the event of the owner/occupier moving, the bin must remain at the address nominated on this form.**
2. The bin will be serviced on the normal collection day. Council will collect the 120L bin and replace it with a 240L bin.
3. PLEASE LEAVE THE 120L BIN AT THE FRONT OF THE PROPERTY FOR COLLECTION. THE COUNCIL WILL TRANSFER WASTE TO THE NEW BIN.
4. Maintenance including repairs and parts replacement will be provided by Council, however reasonable care of the bin shall be taken by the resident.
5. An additional charge will be levied on a pro-rata basis from the commencement date of the additional service. This will be charged to the rates account.
6. If you are not the owner of the property please have the owner or agent request the service on your behalf.
7. The current additional charge is \$213.00 p.a. **[23/24 financial year]**.
8. This agreement will not commence until Council has received the signed agreement form.
9. The minimum term for this additional service is 1 year from the date of this agreement.
