

To whom it may concern.

After the passage of some years, and the advance of technology especially AI, I seek to update the detail contained in my formal request for certain personal information to be suppressed from public view on my designated return and not uploaded to the internet. I understand that a separate copy will be retained for record purposes but a redacted copy only will be made publicly accessible.

PRIVACY AND PERSONAL INFORMATION PROTECTION ACT 1998 - Part 6 Public Registers

58 Suppression of personal information

- (1) A person about whom personal information is contained (or proposed to be contained) in a public register may request the public sector agency responsible for keeping the register to have the information—
 - (a) removed from, or not placed on, the register as publicly available, and
 - (b) not disclosed to the public.
- (2) If the public sector agency is satisfied that the safety or well-being of any person would be affected by not suppressing the personal information as requested, the agency must suppress the information in accordance with the request unless the agency is of the opinion that the public interest in maintaining public access to the information outweighs any individual interest in suppressing the information.
- (3) Any information that is removed from, or not placed on, a public register under this section may be kept on the register for other purposes.

The returns of designated persons include the means of identifying my place of residence, my formal first name, my middle name, surname and signature.

I have two key concerns with the capacity for any person to view and take a copy or image of all of the above identified information in my designated return: being the potential for identity theft and the financial implications arising from that theft, and the safety of my family including my daughter. These

concerns are magnified by the increasing use of AI to sweep the web for information and use it with few, if any, safeguards. Once information has escaped, it can never be retracted.

It is impossible to predict when any action of a Local Government employee in connection with their employment may be seized upon by a person who is less than mentally stable. Key identifying information, such as place of residence, needs to already be in a state of suppression; it is too late to put that into effect after an event. In the course of my long Local Government employment, at a number of councils, I have had one colleague who was greatly impacted by vandalism at his home perpetrated by a disaffected resident. This is a matter of great concern to me.

I am *extremely* concerned about the potential for identity theft – which has massive implications for the person concerned and their family. I have been very vigilant for many years not to have my formal first name, middle name, surname, signature and address together in one place in any accessible forum. This includes the return of designated persons which I have previously filled out.

Accordingly, I believe to have this information in the register with the inevitable potential for it to be copied, released on the internet, and even scraped by AI, effectively compromises my privacy, my safety and that of my family, and seriously impacts my psychological well-being in a manner that meets the criteria for suppression.

I understand that my name and my employment with Ku-ring-gai Council needs to be publicly accessible. However, I formally request that my middle name, my signature and the information identifying my private home (being the only property in which I have an interest and not being located in the Ku-ring-gai Local Government Area) be suppressed and redacted from any copy made publicly available including on the internet. The register should only contain my first and surname and the fact that I am a paid employee of Ku-ring-gai Council as all other matters other than my home are NIL and NA.

I trust you will accede to my request for suppression as essential to ensure that this information is not available for release onto the internet and accessible to AI with all the attendant potential for misuse as noted above.




