A search of Council plans or other Operations records will be undertaken on request after prepayment of a search fee. The minimum fee, as set out in the current copy of Council's 'Fees and Charges', provides for a half-hour search with further searching being charged at the same rate per half hour or part thereof.

Council holds records of drainage easements across private property in favour of Council. Council may not hold records of interallotment easements in favour of private property <u>and</u> <u>does not show internal house drainage pipe lines and services.</u>

Applicants are to specify exactly what is required, bearing in mind that searches can be very time consuming.

Engineering plans relevant to a single property or street will normally be included within the initial fee. Detailed searching of the Department's records, even for small areas, may not be included.

Although the record system is of long-standing, its completeness and the precision of data contained maybe somewhat variable. It cannot be guaranteed that information requested will be found or that what is found, accurately reflects field conditions.

The Search will normally be conducted as soon as possible and you will be advised by telephone when the information is available.

When a search has taken more time than that covered by the fee paid, no material will be made available until additional payment is received.
